The updated NSAID warnings could matter to your heart

The U.S. Food and Drug Administration (FDA) has recently required an update to the Drug Facts labeling of all adult, children's, and infants' **non-aspirin OTC nonsteroidal anti-inflammatory drugs (NSAIDs)**, for example Motrin®, Advil®, and Aleve® products. These changes strengthen and expand existing warnings relating to the risk of heart attack and stroke associated with NSAIDs.

The chart below shows the differences between the old label and the updated label in the warnings section.

Ask your healthcare professional if you have questions about the warnings.

Old NSAID warnings

Stomach bleeding warning

This product contains an NSAID, which may cause severe stomach bleeding. The chance is higher if you:

- are age 60 or older
- have had stomach ulcers or bleeding problems
- take a blood thinning (anticoagulant) or steroid drug
- take other drugs containing prescription or nonprescription NSAIDs [aspirin, ibuprofen, naproxen, or others]
- have 3 or more alcoholic drinks every day while using this product
- · take more or for a longer time than directed

Ask a doctor before use if

- · stomach bleeding warning applies to you
- you have problems or serious side effects from taking pain relievers or fever reducers
- you have a history of stomach problems, such as heartburn
- you have high blood pressure, heart disease, liver cirrhosis, kidney disease, or asthma
- · you are taking a diuretic

When using this product

- · take with food or milk if stomach upset occurs
- the risk of heart attack or stroke may increase if you use more than directed or for longer than directed

Stop use and ask a doctor if

- · you experience any of the following signs of stomach bleeding:
 - · feel faint
 - · vomit blood
 - · have bloody or black stools
 - · have stomach pain that does not get better
- · pain gets worse or lasts more than 10 days
- fever gets worse or lasts more than 3 days
- redness or swelling is present in the painful area
- · any new symptoms appear

Heart attack and stroke warning

NSAIDs, except aspirin, increase the risk of heart attack, heart failure, and stroke. These can be fatal. The risk is higher if you use more than directed or for longer than directed.

- you have problems or serious side effects from taking pain relievers or fever reducers
- you have a history of stomach problems, such as heartburn you have high blood pressure, heart disease, liver cirrhosis, kidney disease, asthma, or had a stroke

- any new symptoms appear
